THE PRESIDENT'S REMARKS

The academic year from 1 July 2006 to 30 June 2007 saw our new governance in full operation, the first full meeting of the Board being held on October 17th 2006 with the Praeses presiding as Acting Chair. Present at this first meeting were: Fr. James McConica, C.S.B. *Praeses*, Dr. Hans Abromeit, Dr. Richard Alway, Mr. William Broadhurst, Mr. Robert Chisholm, Fr. Kenneth Decker C.S.B., Superior General of the Basilian Fathers, Mrs. Nicole C. Eaton, The Honourable Henry N.R. Jackman, Mr. Frank Morneau, and Dr. Ron B. Thomson, Treasurer of the Institute. Bishop John Boissonneau, representing and appointed by the Chancellor, sent his regrets.

As a first order of business the Board elected as Chair, Nicole C. Eaton, and as Secretary, Fr. James Farge C.S.B., Fellow, Librarian of the Institute. The Finance Committee was constituted with the following membership: R. H. M. Alway, H.G. Abromeit, W. Broadhurst, R.W. Chisholm, J.K. McConica, C.S.B. and R.B. Thomson. The Protocol defining the continuing relationship between the Pontifical Institute and the University of St. Michael's College was approved, as it had been earlier by the Collegium, thus clearing the way for the Institute to proceed with significant new autonomy and community relationships, but still and essentially as a part of St. Michael's and the Toronto community of medievalists.

During this same period, the Institute learned that the President of the Andrew W. Mellon Foundation of New York had approved officially a matching grant of up to (U.S.) \$1,250,000 to endow the existing Post-Doctoral Fellowships on a permanent basis. This confirmed discussions held in Toronto in the spring of 2006 with Dr. Joseph Meisel, the Mellon Program Officer for Higher Education, who confirmed the Foundation's keen and continuing interest in the programme. This initiative of the Mellon Foundation also provided the new Board with a very specific objective for immediate action.

During the last weeks of 2006 the Fellows attended public lectures by and interviewed a short list of four applicants for the Leonard E. Boyle Chair in Manuscript Studies, all of the public sessions being well attended by medievalists from the Toronto community. In the end, the selection fell on Dr. Michèle Mulchahey as the first occupant of the Chair. At the time of applying, Dr. Mulchahey held a tenured position at St. Andrews University in Scotland, and she joined the Institute as a Fellow on 1 July 2007. Among the candidates there were two American scholars (Dr. Mulchahey being one of them), one Canadian, and one French scholar.

Dr. Mulchahey earned her international reputation with an academic career on two continents. Originally from Los Angeles, her first studies were at Rice University in Houston, Texas. From Houston she came to Toronto and in

1981, took an M.A. degree in Medieval Studies. With further studies at the Pontifical Institute she qualified as a Licentiate in Mediaeval Studies in 1985, and was awarded the Ph.D. in Medieval Studies at the University of Toronto in 1989. After taking up her first academic appointment, she continued working at the Institute under the direction of Father Leonard Boyle and concluded her formal academic qualifications in 1996 with a dissertation fulfilling the requirements for a Doctorate at the Pontifical Institute – the M.S.D.

Our new Boyle Professor is only the twelfth of the Institute's alumni - and the third woman among them - to hold both the M.S.L. and M.S.D. degrees from the Institute. Her research for the latter degree was published by PIMS in 1998 as, "*First the Bow is Bent in Study...*", *Dominican Education before 1350*, a book that immediately established her reputation as a young scholar of conspicuous promise. In 1997 she brought out as well, *Fra Nicola da Milano, "Collationes de Beata Virgine", A Cycle of Preaching in the Dominican Congregation of the Blessed Virgin Mary at Imola, 1286-87* in the series, Toronto Medieval Latin Texts (PIMS 1997).

ACADEMIC ASPECTS

The four new Mellon Post-doctoral Fellows who were at the Institute in 2006-2007 were again drawn from an international field of thirty applicants.

Alexander Andrée came to us from Sundbyberg, Sweden. His doctoral thesis – defended at Stockholm University – was a critical edition with an introduction and translation of the *Glossa ordinaria in Lamentationes Ieremie prophete, Prothemata et Liber I*, of Gilbertus Universalis. Dr. Andrée earlier studied codicology and palaeography in Rome under the late Fr. Leonard Boyle, O.P. At the Institute, he continued editing the books of the biblical *Glossa ordinaria* with the Gloss on the Gospel of St. John, probably the work at least in part of Anselm of Laon, who was the focus of study of a Mellon Fellow four years ago.

Holly Grieco, a Lecturer at Bryn Mawr College, completed her doctoral work at Princeton University in history on Franciscan inquisitions and inquisitors in southern France in the wake of the Fourth Lateran Council. In Toronto, she concentrated on the formation of the Franciscan cult of St. Louis of Anjou as a model of orthodox spirituality. By utilizing archival resources from Marseilles, where a yearly fair was established in his honour, she investigated also the integration of Louis' cult into the fabric of urban life.

Alessandro Palazzo, who undertook his studies at the University of Lecce, received his Ph.D. with a dissertation entitled, "Ulrico di Strasburgo, *De summo bono*, lib. IV tract. III: a critical edition and doctrinal study." He has

held fellowships at the University of Notre Dame, Indiana, at the Herzog August Bibliothek of Wolfenbüttel, and at the Catholic University of Eichstett. At the Institute he examined the teaching of *fatum* and providence in the works of Albertus Magnus, Ulrich of Strasbourg, Dietrich of Freiberg and Berthold of Moosbrug.

Jochen Schenk from Erlangen, with degrees also from Cambridge (Ph.D.) and Trinity College Dublin (M.Phil. in medieval history) explored the spirituality of the military orders of the Temple and the Hospital in medieval France. Although much has been made lately of the Templars and the Knights Hospitallers of St. John the Baptist, careful scholarly study and discussion of these influential associations precisely as religious orders has not been prominent over the years, let alone in recent publication.

In addition to these four new Mellon Post-doctoral Fellows, a further four young scholars were enrolled in the programme.

Sarah Byers, a graduate of Birkbeck College in the University of London, attained her Ph.D. at the University of Toronto, and chose as her Licentiate topic, "Human Action and Affectivity in the Thought of Augustine."

Elena Lemeneva, from the Central European University, proposed a topic from a corpus of anonymous Latin sermons assembled over the second half of the 13th century in the Benedictine Abbey of St. Lambrecht in Upper Styria.

Kriston Rennie, a graduate of the University of Lethbridge with further degrees from the University of St. Andrews and King's College London, examined evidence for the training of Legates and for their canonistic knowledge in the times of Gregory VII (1073-85).

Massimiliano Vitiello came to the Institute from the University of Münster, where he was a Humboldt Fellow, with earlier degrees from the University of Rome 'La Sapienza' and the University of Messina (Ph.D.). His research topic was: "The Myth of Rome between Late Antiquity and the Early Middle Ages."

The final numbers of documented monastic sites in Ireland dwindles each year. As I stated two years ago, the numbers were down to three. Since then I have found a hundred or so other obscure sites. These are dated from the time of St. Patrick so, needless to say, there are sparse remains if any. Most times they are identified by a cemetery, with or without a derelict Church of Ireland church. Slowly they are being catalogued and photographed. Some of the sites with more remains are located on quite inaccessible islands. The most important site is on Inishmurray off the coast of Sligo, where there are the best remains of an early monastic site in Europe. It is very difficult to get to as there is no jetty and can only be accessed when the sea is not rough. So far I have tried on six separate days to get there with no success. The problem is that there are many of these sites which have no known location and others that are difficult, or even impossible, to find on ordnance survey maps.

THE INSTITUTE LIBRARY

In the academic year 2006–2007 we accessed just under 1100 monographs, texts, and catalogues, about 200 bound volumes of journals, 45 reels of microfilm, and 10 CD-ROMs. Our holdings now comprise approximately 120,000 printed volumes and 9,500 manuscript works on about 8300 reels of microfilm gathered from over 500 different libraries and archives. We have 8500 uncatalogued books on microfiche, and nearly 800 CD-ROMs and DVDs, 770 of which contain images of letters written by the popes from the 13th to the mid-15th century. We are the sole Toronto licensees for several on-line resources, notably the CETEDOC (*Corpus Christianorum*), *Per Littera Apostolica* (calendars of papal letters), and the In principio database of Latin manuscript incipits. We have joined with Robarts Library of the University of Toronto to fund access in library, office, and at home for four additional sources: the *Monumenta Germaniae historica*, the Library of Latin texts online, the Database of Latin dictionaries, and the Archive of Celtic-Latin literature.

Caroline Suma, who served as Library Technician for 27 years, submitted her resignation towards the end of 2006. Patrons will remember her warm welcome and helpful service – always given with a smile. The Library staff joins me in extending our thanks to Caroline for her dedicated work and in offering our best wishes for her new pursuits. Dr. Greti Dinkova-Bruun filled the vacant position temporarily while the Search Committee sifted through 78 applications for the job. On May 1 we welcomed Michael Sloan as our new Library Technician. Bill Edwards continues on a part-time basis as Reference Librarian and manages Inter-library loans, journal acquisitions, and the microform and digital collections.

During the academic term the number of PIMS patrons averaged 35 per day. This year 480 patrons registered with us: 83 from PIMS and the CMS, 43 who listed USMC as their primary affiliation (mostly faculty and students of the Faculty of Theology), and 290 from 32 other U of T Departments (primarily History, English, Fine Arts, Classics, and Philosophy). We had 34 visiting patrons from the United States and 16 from countries overseas.

Our Inter-Library loan service filled 32 requests for books or photocopies of articles. It declined 131 other requests for items that are available elsewhere in Canada and for reference or palaeography books which we do not lend.

The acquisitions budget was enhanced this year by \$11,500 from the Endowment Fund of the Friends of the Library. The Friends also contributed \$5,000 for acquisitions in the *Monumenta Germaniae Historica* series and for binding of books in that collection. Some of this fund was used as part of our contribution to make the MGH available on line.

The Joan and Clifford Hatch Foundation made a gift of \$20,000.00, half of which was used to replace the aging 3-M system with the new Sentry Security system. The rest of the donation will fund additional shelving to house the expanding stack collection.

We were also able this year to install wireless connectivity, enabling laptop users to use all the advantages of the internet from any position in the Library.

As funds permit, we continue to conserve, repair, and (when necessary) rebind damaged books conserved in the Joseph Pope Rare Book Room. Prof. David Townsend (CMS) paid to have our Latin MS 1 repaired, using all the original materials. A donation from Steven Pede made the conservation of several other rare books possible.

The Library's existing collection of over 50,000 slides has been enhanced by a donation of several hundred colour slides by Dr. Rosemary Bergman, a retired professor of art history in Ottawa. They are almost all pictures of manuscript illuminations.

Rev. Edward Jackman, O.P. has renewed his gift of funds to purchase books in Hagiography. A large collection of books and research files from the library of the late Prof. John Hine Mundy of Columbia University has been donated by Charlotte Mundy, his widow. Other donations of books came from Dr. Bernice Kaczynksi (for the *Journal of Medieval Latin*), Jennifer Ashworth, Cate Bannon, T.D. DEPARTMENT OF PUBLICATIONS

The Department of Publications has in print about 300 titles in addition to the 68 volumes of *Mediaeval Studies*, the annual journal of the Pontifical Institute. In 2006-2007 the department produced five new titles as well as the 2006 volume of the journal and the Gilson lecture, while undergoing a hold in some of its operations, an extensive review, and a change in directorship. After a review committee consisting of Andy Orchard, Bill Harnum, and Konrad Eisenbichler reported to the *praeses* in March 2007, the director, Ron B. Thomson, stepped down, and I was asked to fill in as editor in chief of the department while continuing as editor of the journal. The other remaining members of the department are Jean Hoff and Fred Unwalla, editors, and Angela MacAloney, administrative assistant. In addition, a Publications executive was formed including Bill Harnum (chair), James Carley, and Andy Orchard, with the *praeses* and editor in chief as *ex officio* members.

Net income from sales for the 2006-2007 financial year was \$238,612, up 23% from the preceding year. A reception at the Pontifical Institute during the Mediaeval Academy of America meeting in April included a major sale of back stock, which contributed to the revenues from sales at the end of the financial year.

FRIENDS OF THE LIBRARY

During the 2006-2007 academic year, I have been most grateful to Connell Monette, who has been an extremely able administrative assistant, as indeed had been the case in the previous year and in the past. He helped co-ordinate our events and has been the voice that has answered queries and that has helped keep things running smoothly. This autumn, with his dissertation almost completed, he is off to Morocco to his first full-time academic post. We wish him well and will hope to welcome him back to Toronto and the Library on his trips home.

This year for our special project, we once again turned our attention to books. Following our success of five years ago (2001-2002) in raising money to restore, replace and complete our collection of volumes in the Rolls Series, we decided to focus on another much consulted series, the *Monumenta Germaniae Historica*. A survey had indicated that our holdings of this indispensable compilation of medieval historical sources were incomplete, and that some volumes required mending, rebinding, and so forth. With the generous support of the Friends, this series will now receive the attention needed to bring it up to date and make it readily available for use.

As has become our custom, the Friends sponsored two lectures. On 10 November, Joe Goering, of the University of Toronto's Department of History, the Centre for Medieval Studies, and St. Michael's College Christianity and Culture Programme, spoke on "Medieval Studies and the Holy Grail," a lecture based on his new book, *The Virgin and the Grail*. The capacity audience was fascinated by the haunting murals of the Virgin holding a dish emitting flames found high in the mountains of eastern Spain. The eighth lecture in memory of Leonard E. Boyle, O.P. was given on 11 April by a former student of Father Boyle, Daniel Williman, Professor of Latin and History at the State University of New York, Binghamton. Professor Williman's lecture, "Leonard Boyle, the Saint-Denis Chronicles, and Henry VIII," raised a number of intriguing issues, and the enthusiastic audience agreed that it was just the kind of subject Father Boyle would have enjoyed.

This year we were not able to schedule our usual Christmas Tea, but we have held the raffle prizes for an even bigger raffle in the coming year. We would like to thank the donors for their generosity and their patience.

In the spring on 23 April, the Friends, the Kelly Library and the Centre for Medieval Studies held a tea to say farewell to Carolina Suma (now Valenzuela) after more than 27 years in the Library, at first downstairs in the Kelly Library, and lately, upstairs with PIMS. Unfortunately a family crisis prevented Caroline from attending the gathering. She was toasted, however,

and the speakers acknowledged how through her cheerful readiness to help, she made a difference to the library's patrons. Caroline will be much missed by the Friends for whom she has been a source of information and an extraordinarily willing Committee member.

Our new restricted endowment has grown, this year reaching an amount of over \$230,000. As a result we have been able to give about \$13,000 to the Library for acquisitions. This is a goal the Friends have been working towards for years, and we feel especially pleased to show those who have been loyally helping us that at last we are making a substantial difference to Library acquisitions.

The adopt-a-journal programme continues to attract new donors. We are grateful to our Friends for their generous financial support and for their gifts of books. Without our volunteers and the Committee of the Friends of the Library, we would not be able to accomplish much of what we now do. There are many others who help behind the scenes. I would like to thank all our supporters for their time, their gifts and donations, and for the many other ways in which they have been helping to maintain the Institute Library as a major resource for medieval research.

SINE NOMINE ENSEMBLE FOR MEDIEVAL MUSIC

The close of this season marked the end of another successful year for the Institute's ensemble in residence. Programming and research for this period marked a departure from our usual practice of structuring concerts around uncommonly explored repertoires, people, or events, to venture down rather more frequented avenues—but in an adventuresome way.

In Advent we presented a fourteenth-century Mass for Christmas Day, based on material from the Apt manuscript (Nativity music presented in Advent is surely a sign of the Fall). In February, the era of the Great Schism provided the opportunity to range from the mathematically intricate ars subtilior repertoire to the 'sweeter' music of Dufay and his contemporaries (a gratifying number of pieces mention the capital people and events of those years).

The final concert in April 2007 used the framework of Chaucer's Canterbury Tales to offer music from the English and French worlds of the later fourteenth century.

BENEFACTIONS AND BEQUESTS

The Institute welcomes gifts and bequests in furtherance of its objectives. Donations can be directed to the Institute itself, to the Mediaeval Studies Foundation, or to specific funds and named gifts. All such donations (including books, works of art or other artifacts appropriate to the pursuit of medieval studies) will qualify for Income Tax relief in Canada and in the United States.

The Institute's Library has benefited from its inception from gifts and bequests which have provided the foundation for some of its most important collections. Permanent endowment is sought also for academic positions and projects to which a donor's name can be attached. Named Chairs are being sought to support research and teaching in the central disciplines of medieval thought and culture, particularly in Philosophy, Theology, Liturgy, Canon Law, Art and Archaeology. Named funds may also be established for student scholarships, research grants and visiting professorships. Donors may wish to underwrite an ongoing series of publications, individual publications, or the Institute journal, *Mediaeval Studies*. There are opportunities as well for named or memorial areas in the Institute, including its seminar rooms, areas within the Library, and the Library itself.

MEDIAEVAL STUDIES FOUNDATION

The Mediaeval Studies Foundation holds in trust the endowment funds of the Pontifical Institute of Mediaeval Studies. It exists only to support the work of the Institute and manages trusts and restricted funds directed to specific purposes, disbursing earnings for the operation of the Institute's scholarly programmes. To facilitate contributions from the United States of America, a complementary American Corporation has been established (see below).

THE LEONARD E. BOYLE CHAIR IN MANUSCRIPT STUDIES

The campaign to endow a Chair in Manuscript Studies to honour the late Father Leonard Boyle, O.P. of the Pontifical Institute of Mediaeval Studies was concluded on schedule in the period covered by this Report.

The campaign was initiated in the Spring of 2002, and was supported with a matching grant for all donations from the Andrew W. Mellon Foundation of New York. As is noted above under "The President's Remarks", the generous response to this appeal, coupled with a favourable investment climate, brought the campaign to a gratifying conclusion well within the time allotted.

THE FRIENDS OF THE LIBRARY FUND

The long-term objective of the Friends of the Library Committee is to build up a fund whose earnings would support the purchase of manuscripts, books, periodicals, microfilms, CD-ROM materials, readers, and computer equipment.

THE CARR MEMORIAL FUND FOR PAPAL REGISTERS

The Carr Memorial Collection holds films of medieval papal registers. The Fund allows us to continue acquisition of films and/or CD-ROMS of the registers from A.D. 872 to 1464 including, eventually, the registers of the Avignon popes.

THE MICHAEL M. SHEEHAN MEMORIAL FUND

Created in memory of Father Michael M. Sheehan, the earnings of this fund are used to provide scholarship awards in medieval history or law.

THE EDWARD A. SYNAN MEMORIAL FUND

The earnings from this fund, created by colleagues, former students, and friends of the late Msgr Edward Synan, support studies or research in medieval philosophy.
